## Introduction

The UNFPA Supplies project is working with government to strengthen national supply planning to improve the governments health system. Supply chains supports health system strengthening from forecasting to overall logistics management by ensuring last mile assurance. The project aims to create a more strategic approach to meet the needs of the hardest-to-reach women and girls for modern contraceptives while ensuring regular commodities supplies along with bolstering logistic management system.

## Objective

To strengthen Supply Chain Management (SCM) System and to create an enabling Reproductive Health(RH)/Family Planning (FP) policy environment.

## Outcome

- Every woman, adolescent, and youth everywhere, especially those furthest behind, has utilized integrated sexual and reproductive health services and exercised reproductive rights, free of coercion, discrimination, and violence.
- Improved, equitable access, availability, and utilization of quality basic social services for all, particularly for vulnerable people.

Efficient and timely procurement of a choice of quality assured RH/FP commodities.

- Increased and diversified allocations and use of domestic resources for RH/FP commodities and services.
- Improved Supply Chain Management

### Leadership and Governance:

- Support for National Consensus Quantification workshop for forecasting health commodity needs for fiscal year 2078/79.
- eLMIS roll out training to government Health Service Providers (HSPs) in all 136 Palikas of Madhesh Pradesh.
- Basic Health Logistics Management training for health facility level professionals.
- Established two model learning labs for providing technical supportive supervision in eLMIS.
- Advocate and support for FP sustainability road map.
- Supported “RH review and planning meeting” in Lumbini and Sudurpaschim Province.
- Supported for preparation of detail design, drawing, cost estimate and Structural analysis for Mezzanine floor and rack system for Warehouse, Teku.

### Human Resource for Health:

- Provided Technical Assistance (TA) to PHD, MD, FWD for Strengthening SCM through placement of IT consultant in Management Division.

### Health Information System:

- Produce IEC/BCC materials on Logistics/SCM: Three training manuals related to Basic Health Logistics Management & Procurement printed and distributed to all PHD, PHLMC, and MOSD offices of seven provinces and four UNFPA offices. Similarly, Video documentary on FP program was produced and shared with FWD and UNFPA partners at central and provincial level.
