TERMS OF REFERENCE: Engineering Consultant for YCWSS of ADRA Japan "Health Reform Project"

Purpose of consultancy:	Background: ADRA Japan collaborates with ADRA Nepal, for "Health Reform Project" funded by MoFA Japan in Bardiya district of Nepal. One of the main goals of the project is 'Improve the quality service provision leading to increased availability of nutrition care as well as WASH services which contributes to sustainable and equitable access to nutrition care and WASH facilities through collaboration among government and private sector (Yamaha Motor Co., Ltd., Japan). Furthermore, the project has designed a major intervention to increase the accessibility to safe drinking water in targeted communities (marginalized, Dalit, indigenous, minority, and disabled) The overall objective of the assignment is to provide technical support on design and construction for the installation of YCWSS (Yamaha Clean Water Supply System) along with supervision of all tasks related to construction.

Provide professional and technical assistance to the project staff and contractor Assist the YAMAHA/ADRA team for technical assistance and monitoring for all tasks related to YCWSS. Oversee labor and conduct monitoring during construction, and check whether the construction quality is maintained, identified and deviations are addressed. Support local government and locally formed construction committee (contractor) for the construction of a parts storage shed. In collaboration with the Project Coordinator, timely complete all the assignments and documentation. Prepare all technical documents required for YCWSS construction works. Verify the construction materials as required by YCWSS; Verify and ensure the specification of construction materials and works; Ensure that detailed estimates and design of civil, electrical, and sanitary works are followed properly by contractor; Conduct the after-construction tests of infrastructures as prescribed by
