Project Impact: Supporting children from underprivileged families who face challenges in completing their education.

Despite significant improvements in education in Nepal over the past 20 years, the literacy rate stands at 76%, and many children still face challenges in completing their high school education. These challenges include the need to seek employment or work at home to support their families. Others live in remote areas and must walk 2–3 hours to school, which can be demotivating. Some face pressure to marry young, preventing them from completing their education. For many, the financial burden of providing uniforms and school supplies makes education inaccessible.

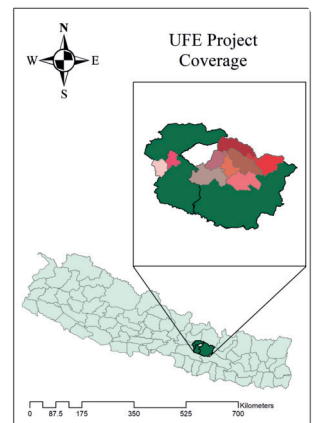
ADRA has been supporting children for over 25 years, striving to uphold education as a right for all and to provide children with options and opportunities for the future. The UFE program provides uniforms, school supplies, and support to around 250 underprivileged children and is implemented through 16 partner government schools.

In addition to sponsorship, ADRA has also been involved in classroom construction and reconstruction, as well providing drinking water systems, libraries and classroom activities through Connections Volunteer Visits. Health and Dental Camps provided school children and staff with essential check-ups and treatment.

Through generous support, we have also been able to provide livelihood assistance, home reconstruction and medical support to some families of sponsored students.

The project is funded by ADRA Korea, ADRA Japan, and a private grant from Australia.

SUNILA'S STORY



Sunila, originally from Dolakha District, now lives in the Khokana Leprosy Colony. A diligent and determined student, she is currently studying in Grade 7.

Since the age of seven, Sunila has been living with her aunt, Radhika, who is a leprosy patient residing in the colony built by ADRA Nepal. Because her aunt is unable to walk, Sunila has taken on the responsibility of caring for her. She manages the household chores while also attending school regularly. Although she longed to stay with her parents in the village, she remained with her aunt to continue her education and provide support.

ADRA Nepal has been providing sponsorship for Sunila from Grade 1 through Grade 7, helping ease her family's financial struggles. With this support, she has been able to focus on her studies and is making steady progress—she recently completed Grade 6 with a GPA of 3.4. "I am very happy to receive ADRA Nepal's sponsorship," Sunila shares. "It has allowed me to continue my studies, and I am working hard because I want to become a doctor in the future."

Sunila's story is one of resilience and determination. With the encouragement and support she has received, she is building a brighter future for herself—and inspiring others along the way.
